rates to effectuate the repeal of the Utility Receipts Tax ("URT") under House Enrolled Act 1002 (the "Act"). On March 16, 2022, the Act was signed into law by Governor Eric Holcomb, removing the URT from utility bills for usage beginning July 1, 2022.
