**PUBLIC NOTICE**  
IN THE MATTER OF APPLE VALLEY UTILITIES, INC.'S 30-DAY FILING TO REDUCE RATES TO EFFECTUATE A REPEAL OF THE UTILITY RECEIPTS TAX  
PUBLIC NOTICE is hereby given that, on or about May 2, 2022, Apple Valley Utilities, Inc. filed with the Indiana Utility Regulatory Commission 30-Day Filing to reduce rates to effectuate the repeal of the Utility Receipts Tax ("URT") under House Enrolled Act 1002 (the "Act"). On March 16, 2022, the Act was signed into law by Governor Eric Holcomb, removing the URT from utility bills for usage beginning July 1, 2022. This removal is approximately a 1.46% reduction in monthly electric bills. A Commission decision on this 30-Day Filing is anticipated no sooner than thirty days after the date of filing.
