STIPULATION AND AGREEMENT IN LIEU OF PREHEARING CONFERENCE

Petitioner Indianapolis Power & Light Company ("Petitioner" or "IPL"), by counsel and on behalf of the Indiana Office of Utility Consumer Counselor ("OUCC"), the IPL Industrial Group ("Industrial Group") and the Citizens Action Coalition of Indiana, Inc. ("CAC"), collectively the "Parties", and in accordance with 170 IAC 1-1.1-15(e), hereby submits the Parties' agreed proposed procedural schedule for the Indiana Utility Regulatory Commission's ("Commission") consideration and approval in this Cause in lieu of conducting a prehearing conference:

- 1. <u>IPL Prefiling Date</u>. IPL prefiled with the Commission its prepared testimony and exhibits constituting its case-in-chief on July 24, 2019.
- 2. <u>OUCC/Intervenor Prefiling Date</u>. The OUCC and any intervenors should prefile with the Commission the prepared testimony and exhibits constituting their respective cases-in-chief on or before October 7, 2019. Copies of same should be served upon all parties of record.
- 3. <u>IPL Rebuttal Prefiling</u>. IPL should prefile with the Commission its prepared rebuttal testimony on or before October 23, 2019. Copies of same should be served upon all parties of record.
- 4. <u>Evidentiary Hearing</u>. The Parties request that the evidentiary hearing in this Cause be set and duly noticed for November 12, 13, or 14, 2019. In the event this date is not available on the Commission's calendar, the Parties request the Commission fix the date for the evidentiary hearing as soon as possible thereafter, and if necessary convene an attorneys' conference via telephone so that the parties may discuss a mutually agreeable date.

5. <u>Post-Hearing Briefing Schedule</u>. The Parties have agreed to the following posthearing briefing schedule:

November 27, 2019 - IPL's Proposed Order

December 10, 2019 - OUCC/Intervenor Proposed Order/Exceptions

December 20, 2019 - IPL's Reply

6. <u>Discovery</u>. Discovery is available for all parties and should be conducted on an informal basis. Any response or objection to a discovery request should be made within ten (10) calendar days of the receipt of such request. After October 7, 2019, the response or objection time shall be made within five (5) business days. Any discovery request received after noon on a Friday or the day before a state holiday or after 5:00 p.m. on any other business day shall be deemed to have been received on the next business day. The last discovery response due date shall be three business days before the evidentiary hearing.

Counsel for IPL has contacted counsel for the Parties and is authorized to represent that

they have agreed to this stipulated procedural schedule.
