You are hereby notified that on this date the Indiana Utility Regulatory Commission ("Commission") has caused the following entry to be made:

On October 15, 2025, Indianapolis Power & Light Company d/b/a AES Indiana ("Petitioner"), AES Indiana Industrial Group, Walmart, Inc., Rolls-Royce Corporation, and City of Indianapolis (jointly "Settling Parties") filed their Joint Motion for Leave to File Settlement Agreement and for Modification of Procedural Schedule. On October 24, 2025, the Office of Consumer Counselor ("OUCC") filed its Response to the Joint Motion for Modification of Procedural Schedule. On October 27, 2025, an attorney's conference was held to discuss the modified procedural schedule. The Presiding Officers now modify the procedural schedule in this matter:

1. **Settling Parties' Prefiling Date.** Petitioner prefiled with the Commission its prepared settlement testimony and exhibits on October 22, 2025.

2. **Non-Settling Parties' Prefiling Date.** The OUCC and any non-settling parties shall prefile with the Commission the prepared testimony and exhibits on or before December 12, 2025. Copies of the same shall be served upon all parties of record.

3. **Settling Parties' Rebuttal Prefiling Date.** Settling Parties shall prefile with the Commission its prepared rebuttal testimony on or before January 9, 2026. Copies of the same shall be served upon all parties of record.


4. **Attorney's Conference.** On January 20, 2026 at 1:00 p.m., an Attorney's Conference will be held via Teams. Parties are expected to have their intended witness order, which should include estimated amount of time for each witness.

5. **Settlement Hearing.** This matter shall proceed to an evidentiary hearing to commence at 9:30 a.m. on January 28, 2026 in Room 222 of the PNC Center, 101 West Washington Street, Indianapolis, Indiana. The Commission reserved the following additional dates for the evidentiary hearing, should they be needed: January 29 to January 30, 2026. At such time, the settlement testimony of the Settling Parties and testimony of the Non-Settling Parties shall be presented, and their respective witnesses examined. Thereafter, Settling Parties shall present their prefiled rebuttal evidence as well as any additional evidence rebutting evidence adduced on cross-examination of the witnesses. If the parties reach settlement, the agreement and supporting testimony and exhibits shall be submitted to the Commission at least ten business days prior to the evidentiary hearing.

6. **Post-Hearing Filings.** The Settling Parties shall file their proposed order on or before February 2, 2026. The Non-Settling Parties shall file their respective proposed orders and/or exceptions to the Settling Parties' proposed order on or before February 17, 2026. The Settling Parties shall file their reply to any other proposed orders of any party but the Settling Parties, on or before March 3, 2026.

7. **Ind. Code § 8-1-2-42.7(e) Deadline Extension.** This schedule constitutes an extension of 86 days of the schedule established in our July 1, 2025 scheduling docket entry, with the original hearing date of November 3, 2025 continued to January 28, 2026. Therefore, pursuant to Ind. Code § 8-1-2-42.7(g), the 300-day deadline established by Ind. Code § 8-1-2-42.7(e) is extended by 86 days to June 24, 2026.
