You are hereby notified that on this date the Indiana Utility Regulatory Commission ("Commission") has caused the following entry to be made:


On April 12, 2024, the Indiana Office of the Utility Consumer Counselor (“OUCC”) filed its Motion for Two Additional Public Field Hearings. In this motion, the OUCC noted Ind. Code § 8-1-2-61(b) requires the Commission to hold at least one public field hearing in this Cause. The OUCC requested two additional public field hearings be held due to the size of Duke Energy Indiana, LLC’s service territory. On May 6, 2024, the OUCC filed correspondence from State Senator Shelli Yoder and State Representative Matt Pierce requesting that a field hearing be held in Bloomington.

The Presiding Officers, having reviewed the filings in this Cause, GRANT the OUCC’s motion. Four field hearings will be scheduled in this Cause, the first of which will commence at 6:00 p.m. (local time) on June 4, 2024, in the Oakley Auditorium at Ivy Tech Community College, located at 8000 S. Education Drive, Terre Haute, IN 47802. Additional public field hearings will be scheduled in Bloomington, Fishers, and New Albany.
