You are hereby notified that on this date the Indiana Utility Regulatory Commission ("Commission") has caused the following entry to be made:

On May 24, 2023, CenterPoint Energy Indiana South Industrial Group ("Industrial Group"), on behalf of itself, the Indiana Office of Utility Consumer Counselor ("OUCC"), and the Citizens Action Coalition (collectively, "Moving Parties"), filed a motion to modify ("Motion") the procedural schedule established on February 6, 2023, in this Cause. In support of this request, the Industrial Group set forth a chronology of discovery steps that it has taken, including agreeing to informal extensions of time for CenterPoint Energy Indiana South ("Petitioner") to respond to certain discovery requests. The Industrial Group asserts that it and Petitioner are working to resolve ongoing discovery issues. The Industrial Group also indicated in the Motion that the Moving Parties collectively need additional time to conduct and complete discovery. According to the Motion, CEI South does not take a position regarding the Moving Parties' request.

The Presiding Officers, having reviewed the Motion and finding good cause to support the request, GRANT the Motion. The previously scheduled OUCC and Intervenor prefiling deadline is extended to September 13, 2023. Petitioner's rebuttal testimony filing deadline is extended to October 23, 2023. The August 24, 2023 evidentiary hearing is vacated and reset to commence at 9:30 a.m. on November 2, 2023, in Room 222 of the PNC Center, 101 West Washington Street, Indianapolis, Indiana.
