(a) Metered User Block Schedule:

Non-Recurring Charges;

(d) Tap Charge

5/8" x 3/4" meter tap	\$1,510.00
5/8" x 3/4" meter tap, with bore	1,960.00
5/8" x 3/4" meter tap, no excavation	1,180.00
5/8" x 3/4" meter tap, pre-installed	1,320.00
5/8" x 3/4" meter tap, pre-installed, no excavation	990.00
5/8" x 3/4" meter tap, water service only	810.00

The charge for a tap larger than the 5/8 inch meter tap shall be the cost of labor, materials, power machinery, transportation, and overhead incurred for installing the tap, but shall not be less than the charge for a 5/8 inch meter tap

(e) Reconnection Charge

Business hours	\$40.00
After hours	80.00

When the service is turned off for non-payment of bill, or whenever for any reason beyond the control of the waterworks, a re-establishment of service is required by any one customer, this charge will be made by the waterworks to cover the cost of discontinuance and re-establishment of service. The charge, together with any arrears due the waterworks, shall be paid by the customer before service will be re-established.

(f) Late Payment Charge

All bills for water service not paid within seventeen (17) days after the bill is mailed shall be subject to a late payment charge of ten (10) percent of the first three (3) dollars and three (3) percent of the excess of three (3) dollars.

(g) Insufficient Funds Charge \$29.00

When a customer's check is not honored due to insufficient funds, a charge for processing same will be charged by the Town of Ellettsville in the amount of twenty (20) dollars.

(h) After Hours Emergency Service Charge \$60.00

This charge will be made for any trip made after hours to the customers premise, at the request of the customer, for conditions on the customer's side.

(i) Meter Deposit \$50.00

This refundable deposit is to be paid for new services
