REVISED PETITION TO INTERVENE

Comes now Darrell Boggess, pursuant to 170 IAC 1-1.1-11, and file my Petition to Intervene in the above-captioned proceeding and, in support thereof, state as follows:

1. My January 24 Petition to Intervene, including language provided by others who I believed to have more experience with these proceedings, was interpreted differently than my intent. In my view, that is just cause for this Petition to be granted.
2. I reside at 3934 East Saratoga Drive, Bloomington Indiana where I have resided since July 1977.
3. I am a residential net-metering customer of Duke Energy Indiana (Duke) and have a direct, immediate, and substantial interest in the subject matter of this proceeding, as required for intervention under 170 IAC 1-1.1-11. Specifically,
 - a. I pay Duke rates and charges for residential electric service.
 - b. I am a Duke net metering customer with a solar photovoltaic system installed and interconnected to the Duke distribution system in 2011 and expanded in October 2017 to power an electric car.
 - c. The electric bill which I pay Duke each month is directly affected (reduced) by the credit that my solar photovoltaic system earns for me as a net metering customer.

d. The Duke net metering tariff does not state, as provided in Senate Enrolled Act 309, that the net metering status will continue for a successor-in interest until the earlier of removal or replacement of the Customer's net metering facility or July 1, 2032 or July 1, 2047.

e. This right to future Net Metering service is economically valuable to me and successors in interest for my residence when it is sold, which at my age is likely to be within the next twenty years.

f. Duke has not updated its net metering tariff to acknowledge this economically valuable status by identifying the different classes of net metering owners as created in Senate Enrolled Act 309.
