

**NOTICE OF COMPLETION OF APPEAL**

Comes now the Muncie Sanitary District (“Petitioner” or “MSD”), by counsel, and for its Notice of Completion of Appeal states as follows:

1. On November 27, 2019, the Commission issued its Final Order in this matter.
2. On December 18, 2019, Delaware County Regional Wastewater District (“DCRWD”) filed its Notice of Appeal with the Indiana Court of Appeals, cause number 19A-EX-02964.
3. On July 22, 2020, the Indiana Court of Appeals issued its Final Order.
4. On September 8, 2020, DCRWD filed a Petition to Transfer to the Supreme Court of Indiana.
5. On February 4, 2021, the Supreme Court of Indiana unanimously denied DCRWD’s Petition to Transfer.
6. All appeals in this matter have now been exhausted.


