I have no comments about the need for any of the proposed projects. The Utility staff members who have been with the Utility for many years know their system and needs. Most of my comments concern the financing plan for the work and the sustainability of implementing the distribution system replacement in the future. I'm going to refer to Cause 44760 which was approved in 2016 along with the current petition since they are similar and overlap in scope. I had previously submitted comments to the IURC for Cause 44760 and today's comments mirror some of those presented in 2016.

The rate increase for Cause 44760 was phased in over 2 years (26% and 17%) The rate increase for Cause 45073 is to be phased in over 3 years(19%, 15.5% and 8%). The total increase for both Causes is 85.5% over a 5 year period which is a substantial increase. Cause 44760 included mostly distribution system replacement work, except for a \$10 million line item for a treatment plant supply well study and land acquisition. Cause 45073 included \$107 million for distribution system replacement with \$27 million for treatment plant and booster station work and \$6 million for wholesale water work. The financing for Cause 44760 included a bond issue costing \$59 million thru 2038 with a usable \$35 million. (My definition of usable is the total bond issue cost minus all bond fees and minus the set aside amount equal to one year bond payment). Interest, fees and one year bond payment for Cause 44760 total \$24 million. Cause 45073 will require a bond issue costing \$213 million thru 2040 with a usable \$132 million. Interest, fees and one year bond payment for Cause 45073 total \$80 million. Adding both bond issues yields a total cost of \$272 million with a usable amount of \$167 million. We will be paying \$105 million for non construction costs! I understand this is the way bonding works but there are better financing plans for our community which has many of its folks living day to day.

The whole reason for the above review was to point out that to continue at this rate--85.5% of rate increases over 5 years is not sustainable especially when the replacement of the distribution system will only be 7% complete after this 5 year period. (1+1.5+1.5+1.5+1.5) I hope the IURC will help the Utility investigate alternate financing plans for the sake of the rate payer's pocketbooks and the sustainability of the Utility's line replacement program. I do not believe the Utility can bond itself out of this problem. If an alternate acceptable financing plan is not used, I predict there will not be the political fortitude to provide future funding of the line replacement program because of the burden on the rate payers. This will result in the Utility possibly replacing less than 100 miles of lines, leaving 500 miles of old cast iron lines still in service.

I believe that bond issues need to be reserved for specific and shovel ready projects and not "banked" until needed. I do not have any problem with a bond issue for the \$28 million in treatment plant and booster plant work. I do take issue with not using the \$10 million (less current \$416,000 engineering contract) to partially fund the 6 MG clear well. In the disposition by the Utility's engineer and accountant, they said the Utility does not want to spend the \$9.6 million balance on another project. What a waste of interest money!! It could cost the rate payers \$6 million +/- in interest, fees and one year payment to bond another \$9.6 million. If the IURC has the authority to allow this shift of purpose for the \$9.6 million, please do so.

As far as the funding plan for the distribution line replacement which will last 30-40 years, I believe that project should be funded using rate fees instead of bond issues. The line replacement goal could be lowered to .75% or 7.5 miles/year. According to Cause 45073 the annual cost of the line replacement is approximately \$35 million for the 1.5% replacement rate. Half of that would be \$18 million/year. The proposed rate increase for Cause 45073 would remain at 42.5% with only an \$18 million bond issue, with the balance of the collected fees designated for the line replacement program. The funding plan would include a bond issue to fund the treatment plant and booster station work in the amount of \$18 million (\$28 million minus the \$9.6 million already in the bank from Cause 44760). The \$18 million for the line replacement funding would include the \$9 million saved from the the annual bond payments which have been reduced from \$10,5 million to the approximate \$1,5 million for the \$18 million bond issue. That leaves another \$9 million to be raised, by yes another rate increase--let me make a wild guess of 38% for that increase. But the take away from this plan is that we are done with rate increases for the

life of the line replacement program, except for minor adjustments for inflation. The bonding plan currently in Cause 45073 will in the words of Mr Mounts, require additional rate increases to achieve 100% line replacement. I guess this could require total rate increases totaling 400 % or more to complete.

This alternative financing plan would be a positive for the rate payers and the Utility. The rate payers will pay less in the long run (an additional 38% rate increase instead of over 400% in multiple rate increases) and the Utility will complete a much needed line replacement program. Minimizing rate increases will also make the Evansville area more attractive to businesses considering locating here and help retain our existing businesses.

Cause 45073 has 3 years of line replacement averaging \$35 million/year. In the previous Cause 44760 the annual line replacement expenditure was \$24 million. The Utility found out that even with the \$24 million amount of work, the bid prices were higher than anticipated, partially because of supply and demand of the local work force. By reducing the annual line replacement budget to \$18 million over 40 plus years, the local labor market will not be stretched to the point that construction costs rapidly increase. The 40 plus year commitment by the Utility will encourage the growth of new Small businesses, MBE's and WBE's in the local market. Banks will be more willing to lend money to startups if they know there is long term market for the startup company's services. An added benefit will be that local contractors who pay local taxes and who invest in the Evansville Community, will not be stretched so thin that their bids have to be increased to the point where more out of town contractors enter the Evansville market and take their profits elsewhere.

I have one last comment about the proposed \$2,506,663 payment to the Civil City of Evansville instead of paying taxes. The Civil City never misses a chance to add revenue. Even though this must be an accepted practice, my question is what services will the Civil City be providing to the Utility for the underground waterline replacement program and treatment plant work to justify the additional tax money? No additional fire or police protection will be required for the line replacement or treatment plant work since the work consists of repairs/replacement to existing facilities already covered by existing payments to the Civil City instead of taxes. I realize that the values of the proposed improvements will increase but why add more misery (approximately \$4 million after interest fees and one year of bond payment) to the ratepayers? Appraisers usually don't assess full improvement costs when the new work replaces older facilities like for like.

I am not an accountant so some of my numbers may be a little loose, but the idea is there. The line replacement rate of .75% is less than suggested national norms but having a modest line replacement program is definitely better than having no program. I realize a justification for the line replacement project centers around reducing the cost of making on the average 340 line repairs costing \$1.4 million every year. I look at that as the cost of doing business and I will accept that annual expense if an alternative financing plan allows thousands of homeowners to remain in their homes because of fewer water rate increases. I hope the IURC will work with the Utility to formulate a long term financing plan for the line replacement, remembering that the plan needs to fit our community profile. I thank you in advance for your time in reviewing and ruling on this Cause.

This is a question regarding fire protection fees to water utility users outside of Town limits.

To whom it may concern:

The Town of Brownsburg is seeking to impose – for the first time – a fire protection fee on residents who are municipal water customers living outside Town boundaries. I am trying to learn whether this is permissible, particularly in the circumstances where the same residents already pay for fire protection through taxes paid to the Brownsburg Fire Territory.

Outside town residents who would be expected to pay for fire protection twice are without recourse to the Town's action. We do not have representation on the Town Council and, although the Town must conduct public hearings regarding this change in ordinance, it does not have to regard ANYTHING THAT outside town residents have to say.

As you may be aware, the Brownsburg Fire Territory is a separate governmental unit created 25+ years ago by the joint action of Brown and Lincoln Townships and the Town of Brownsburg. Residents located outside the Town limits pay taxes to either Brown or Lincoln Township to pay their share of the costs for fire protection services. It is not right that outside town customers pay for fire protection twice.

Town alleges that it is allowed to charge this fee pursuant to I.C. 8-1-2-103(d) and (f). Brownsburg started charging a fire protection fee to its water customers within the corporate boundaries in 2010. However, the Town never adopted an ordinance allowing for the recovery of public fire protection cost, as required pursuant to I.C. 8-1-2-103. As a result, Brownsburg never filed this change in recovery with the Indiana Utility Regulatory Commission ("IURC").

The Town, in 2012, petitioned the IURC for approval of rate and charge difference between property within and property outside the corporate boundaries.

This rate change increased outside user rates, as compared to the rate of those within the corporate boundaries.

At the time this petition was approved, those outside the Town were not charged a separate fire protection fee; only those within the corporate boundaries paid this monthly fire protection fee.

There is a public hearing scheduled for June 26, 2018 regarding a proposed ordinance change, in which the Town will now be charging outside users a separate fire protection fee.

Your Comments::

Recovery of the fire protection fee should come from the fire territory funds and not from municipal water customers.

I have a few questions that I would like answered:

- 1) Is the Town allowed to charge the separate fire protection fee since the Town never adopted an ordinance allowing for the recovery of public fire protection cost?
- 2) Shouldn't this fire protection fee come from the fire territory funds, in which all property owners in the territory are taxed?

Pursuant to I.C. 8-1.5-4-14 since the Town never adopted an ordinance to become subject to I.C. 8-1-2-103(d), Town cannot recover this cost from its water utility customers.

Many of us in the unincorporated areas are looking into the requirements for filing a petition objecting to this fire protection fee charge; we are already paying higher outside user rates and we are taxed for fire protection services provided by the Brownsburg Fire territory.

However, if a petition is filed pursuant to I.C. 8-1.5-3-8.2, subsection (d) allows: At the discretion and upon direction of the court, the file with the petition a bond in the sum and with the security fixed by the court. The bond must be conditioned on the petitioners' payment of all or part of the costs of the hearing and any damages awarded to the municipality if the petition is denied, as ordered by the court.

Why would the petitioners have to potentially post a bond, when it appears that the Town should not be charging any water utility customer this fire protection fee and certainly not those outside of the corporate limits, since we are already paying taxes for fire protection services provided by the fire territory?

Additionally, it appears that we are not allowed to file a petition with the commission regarding this issue because this ordinance change does not meet the requirements established pursuant to I.C. 8-1.5-3-8.3, allowing us to file a petition.

There must be some recourse available to those of us in the unincorporated area to prevent Brownsburg from imposing this additional fee.
