You are hereby notified that on this date the Indiana Utility Regulatory Commission (“Commission”) has caused the following entry to be made:

On February 15, 2022, Northern Indiana Public Service Company LLC (“NIPSCO”), the Indiana Office of Utility Consumer Counselor, and the NIPSCO Industrial Group (collectively, “Joint Movants”) filed their Unopposed Joint Motion for Extension of Time (“Motion”) in the above-captioned Cause. In the Motion, Joint Movants request a one-week extension of time to file rebuttal and cross-answering testimony from February 16, 2022 to February 22, 2022, to provide the parties an opportunity to continue settlement discussions. Joint Movants indicate that they have reached an agreement in principle on less than all issues and request more time to work towards a unanimous settlement. Joint Movants also represent that counsel for intervenors Citizens Action Coalition of Indiana, Inc., Steel Dynamics, Inc., and Archer Energy, LLC, do not oppose the Motion.

The Presiding Officers, having considered the Motion, now GRANT it. Accordingly, the date by which all parties shall file their respective rebuttal or cross-answering testimony is extended to February 22, 2022. All other dates and procedures established by the October 13, 2021 Procedural Schedule in this Cause remain unchanged.
