1 Q. What is the difference between Attachments EAW-1 and Attachments EAW-2 and 2 **EAW-3?** 3 A. Attachment EAW-2 is the bid from 2017, and this is for a different plant design. This bid was submitted before the plant was built, and we were prepared to build pursuant to this 4 bid. Attachment EAW-3 is largely for the same plant as Attachment EAW-1. Some sizes 5 were changed as a result of an error in my original bid. In addition, I did not include the 6 7 tertiary (polishing) lagoon removal in the first estimate. This was the most expensive one to remove because it had apparently been out of service for over 20 years. This was the 8 9 largest dollar value difference. Otherwise, they are very similar.


