SUBMISSION OF SUPPLEMENT TO COMPLIANCE FILING

Petitioner, Indiana-American Water Company, Inc. ("Indiana American" or the "Company"), by counsel, respectfully submits the attached supplemental Test Year End Certification, certifying all utility plant in service as used and useful as of April 30, 2020 and providing the actual value as of that date of all components of rate base including utility plant in service and accumulated depreciation. As referenced in the Submission of Compliance Filing filed on April 29, 2020 in this Cause, as of March 31, 2020, Petitioner had \$1,220,225,173 of Rate Base which was over \$38 million more than the settled Rate Base Cap, establishing that the Cap had been met. The supporting schedules filed in Excel format contemporaneously herewith show that Petitioner has \$1,223,503,664 of Rate Base as of April 30, 2020, over \$41 million more than the

settled Rate Base Cap.¹ As a result, no change is necessary to the rates filed with the April 29, 2020 filing.
