Dear Counselor:

As a customer of B&B Water Project, I object to its proposed 48% rate increase.

B&B Water Project is seeking a 48% rate increase for providing water services. That is a *very* large rate increase given current economic circumstances, and there is reason to wonder how it might be justified. It is hard to see any justification for such a massive increase in its IURC application. Importantly, the IURC's online link to B&B's rate case exhibit is not working; which makes it impossible for consumers (or anyone) seeking further justification to find it.

B&B last received authorization to increase its rates in 2016. At that time, it sought an approximately 25% increase, which seemed reasonable in light of the fact that B&B had not previously had a rate increase since 1991. But now, just six years after its last rate increase, B&B is seeking another increase that would nearly double existing rates for customers. In the absence of any real and verifiable evidence that such an increase, or any increase, is warranted, the application should be summarily denied.

Dear Water Customer:

This Application was filed pursuant to Ind. Code 8-1-2-61.5 without the necessary cost of an IURC hearing; however, a public hearing before the IURC may be held if any public or municipal corporation, ten (10) individuals, firms, corporations or associations, or ten (10) complainants of all or any of these classes affected by the proposed rate change requests a formal public hearing. A written, signed request for a formal hearing must be submitted to the Secretary of the Commission, Indiana Utility Regulatory Commission, 101 W. Washington Street, Suite 1500 East, Indianapolis, Indiana, 46204 and must be received by the IURC within forty (40) days after the date the Application was filed with the IURC and declared complete. In addition, a public hearing may be held if requested by the Utility Consumer Counselor (OUCC).

The proposed increase in the water rate requested by the application is approximately 47.8% and is proposed to be an "Across-the-Board" increase.

In the absence of a written request as described above, there likely will be no hearing conducted by the IURC on this Application. However, this will not decrease the standard of review by either the OUCC or the IURC. While the small utility filing procedure reduces time and expenses for the filing utility, the utility must still make its case in writing and has the same burden of proof that is required in any IURC rate case. The OUCC will assign a team of legal and technical staff to review the utility's request. Further, utility customers may send comments to the OUCC for inclusion in the formal case record. The OUCC accepts comments through its website at www.in.gov/OUCC/2361.htm or by e-mail at uccinfo@OUCC.in.gov.

I am writing in regards to the proposed 47.8% increase to customers of the B and B water corporation. I understand the need for system upgrades, and a moderate increase is understandable, but in this atmosphere of high inflation and increased costs of all utilities, this extreme amount of increase will present a hardship for me. My bill is currently \$27.38/mo; with a 47.8% increase it would be \$40.47, or an extra \$157/year. That is too much.

I am a retiree on a fixed income and consistently use less than the minimum amount of water per month (<3000 gal/ mo.) I already pay the same service charge as everyone else, and am also charged a surplus over the amount I actually use (for example, last month I used 1940 gallons but was charged for 3000).

I think that everyone should be promoting conservation of water, and those of us who pay attention to that should be recognized and rewarded with lower rates. I object to the proposed increase as presented.

To whom it may concern,

This email is a follow-up to the B & B Water Project Board meeting that my husband and I attended last night. Per the request of the Board, I was instructed to send any questions and concerns via email.

- I questioned why the Board has not applied for any increases since 2016. Multiple small increases are
 much more palatable than trying to impose almost a 50% increase to customers at one time. I also
 suggested that they should consider spreading out their proposed rate increase over a 3-year period,
 which would be more acceptable than a one-time large rate increase.
- I asked how their rates compared to other municipalities of similar size. After returning from the meeting and finding the rates online for the City of Bloomington, I'm wondering how B & B can justify charging more than double what the residents of Bloomington are paying. I realize B & B is purchasing water from the City, but B & B's rates far exceed what the residents of the City are paying. Currently, B & B is charging \$8.53 per thousand for the first 3,000 gallons in comparison to the City of Bloomington's rate of \$4.04 per thousand. See chart below. If B & B's hefty increase is approved, they will be charging \$12.61 per thousand in comparison to the City of Bloomington's rate of \$4.03.

- I suggested that they find ways to cut costs. It is very common nowadays that bills are ONLY available
 online, or by email versus sending via the USPS. I specifically asked for my bill to ONLY be sent via
 email. But if they are mailing invoices to the majority of their 1,800 customers, then that is a cost of
 over \$1,000 per month in postage alone, not including the paper and envelope.
- After attending the meeting, I was rather surprised to see how many sit on the Board. I am not quite
 understanding the need for 5 Directors in addition to the 4 officers. I realize they are not all on salary,

but I'm not understanding the need for this many directors. Are the directors each assigned to a district? If so, I am not aware of who my director is and what they can do for me.

• I'm all for updated infrastructure providing it will improve efficiencies. However, if one of your biggest issues is "lost water" mostly due to old outdated meters that are under-registering the proper gallons, as well as water leaks, then why wouldn't B & B first replace the old meters, and locate water leaks, which would then allow them to have accurate readings, thus allowing them to collect additional revenue? Seems like this could be a way of increasing revenue substantially.

We are fairly new customers of B & B. We just moved into our new home in May and have experienced what I would call very out-of-line bills. *My last electric bill was \$294.24 and my last water bill was \$252.71 for a family of 4. I'm not understanding how in the world my water bill can be almost as much as my electric bill! If the 47.8% increase was applied to my last water bill, my bill would have been \$347.68, which would have been MORE than my electric bill.* We also had issues with incorrect meter reads in April BEFORE we moved into our home. When B & B came out and did a manual read versus a Wi-Fi read, they found that our usage was way less than what they billed us for. They ended up adjusting our bill down to \$25.62 for less than 3,000 gallons instead of \$96.10 for 13,080 gallons per the bill that was sent to us. We installed lots of new landscaping in August and watering was a necessary evil for a while. I keep thinking every month that we will finally have a somewhat "normal" water bill, but that remains to be seen.

Yesterday I sent a letter to IURC requesting a hearing about the rate increase request of B&B Water Inc. I believe a 47.5% "Across-the-Board" increase is excessive and not justified by the financial position, current rate and expenses of B&B Water Inc. That water company recently underwent a change in structure going from employee operated to using a contractor to perform operations. The timing of the rate increase coming at the end of the year during the holiday season made responding to the letter we received difficult. The 90+ page application is a challenge for average customers to understand and no reason for the increase is given other than the calculations in the application. Will we get better service, new facilities for water distribution, replacement of aging infrastructure? Why are directors paid so much when, after switching to a contractor to provide all services, they have little to do other than attend a meeting every month or so?

Please take a very critical examination of this rate request. While costs are increasing, in actuality they are increasing less than often reported in the press.
