JOINT PETITIONERS' RESPONSE TO JUNE 26, 2024 DOCKET ENTRY QUESTION

Northern Indiana Public Service Company LLC and Fairbanks Solar Generation LLC, by counsel, respectfully respond to the Indiana Utility Regulatory Commission's request as follows:

# Question

Mr. D'Entremont notes in his direct testimony that market conditions and world events resulted in an increase in underlying capital costs for the Fairbanks project. What factors allowed the Gibson project's underlying capital costs to not experience the same market conditions and world events as the Fairbanks Project. How confident is NIPSCO that these factors will continue?

### Response

The Fairbanks Build Transfer Agreement ("BTA") was negotiated in early 2021. The Gibson BTA was negotiated in mid-2023. Therefore, the prevailing market conditions that increased the cost of the Fairbanks Project (with a BTA that was entered into in early 2021) were already accounted for in the Gibson BTA. NIPSCO has confidence in the protections provided by the terms of Gibson BTA that protect against certain market conditions and penalties for the developer if the project is delayed past the expected commercial operation dates.
