PETITION TO INTERVENE OF HOOSIER ENERGY RURAL ELECTRIC COOPERATIVE, INC.

COMES NOW Hoosier Energy Rural Electric Cooperative, Inc. ("Hoosier Energy") and files this Petition to Intervene in the above-captioned proceeding pursuant to 170 IAC 1-1.1-11 and states the following:

- 1. Hoosier Energy is a rural electric cooperative corporation organized and existing pursuant to the laws of the State of Indiana, with its principal place of business being 2501 S Cooperative Way, Bloomington, IN 47403. Hoosier Energy is a general district corporation as described in I.C. § 8-1-13-23 and has seventeen local district corporation members in Indiana and one electric cooperative member in Illinois.¹
- 2. By an order of the Indiana Utility Regulatory Commission ("Commission") dated April 17, 2024, the Commission commenced an investigation to allow the Commission to consider the public utility status of distributed energy resource

("DER") aggregators who aggregate DERs in the wholesale electricity markets pursuant to FERC Order 2222. The Commission also encouraged those with a substantial interest in the subject matter of the investigation to seek intervention.

- 3. Hoosier Energy and its member system rural electric membership corporations have a substantial interest in this investigation due to the fact that there are substantial DERs in the territories of the members as well as potential aggregators of these DERs. Because of these facts, any decisions of the Commission in this proceeding will have a direct and substantial impact on Hoosier Energy and its members.
- 4. Hoosier Energy's participation in this cause will not unduly broaden the issues or otherwise burden the proceedings. No other party in this matter has a relationship which would adequately protect the interests of Hoosier Energy and its members. Hoosier Energy understands it is bound by the record as it stands at the time its Petition to Intervene is granted. This petition is being filed more than five days prior to the date set for the initial public evidentiary hearing on the merits of this Cause.
