

PUBLIC NOTICE is hereby given that on August 19, 2021, the Board of Directors for Utilities of the Department of Public Utilities of the City of Indianapolis d/b/a Citizens Water ("Citizens Water") filed with the Indiana Utility Regulatory Commission ("Commission") a Verified Petition requesting approvals relating to its plan for the replacement of customer owned lead service lines within or connected to Citizens Water's system (the "Lead Service Line Replacement Plan"). If approved, Citizens Water would address the legacy of lead service lines serving customers on the Citizens Water system in accordance with the provisions set forth in the Lead Service Line Replacement Plan and seek authority to recover costs associated therewith in subsequent proceedings in accordance with Ind.
