
**PUBLIC’S NOTICE OF SETTLEMENT IN PRINCIPLE
AND
NOTICE OF INTENT NOT TO FILE CONTESTING TESTIMONY**

The Indiana Office of Utility Consumer Counselor (“OUCC”) hereby gives notice to the Indiana Utility Regulatory Commission (“Commission”) of the following:

1. The OUCC is scheduled to prefile its testimony in the above-named Cause on or before Monday, October 7, 2024.
2. The OUCC has reached a settlement in principle with Petitioner that needs to be reduced to writing.
3. The OUCC does not intend to file testimony in this Cause in opposition to Petitioner’s case. However, the OUCC intends to file testimony in support of settlement and other supporting documentation in cooperation with Petitioner and in accordance with timeframes established by the Commission’s orders in this Cause.
4. Pursuant to the March 12, 2024 order in this Cause establishing the initial procedural schedule “If the parties reach settlement, the agreement and supporting testimony and exhibits shall be submitted to the Commission at least ten business days prior to the evidentiary hearing.” The hearing is scheduled to take place on Tuesday, November 19, 2024, making the settlement agreement and settlement testimony due no later than Monday November 4, 2024.


