You are hereby notified on this date the Indiana Utility Regulatory Commission ("Commission") has caused the following entry to be made:

On February 22, 2018, Indiana Michigan Power Company ("I&M") filed a Verified Motion to be Dismissed as Respondent, Request for Administrative Notice and Expedited Consideration, and Request for Stay of February 16, 2018 Order ("Motion"). In its Motion, I&M requests that it be dismissed as a Respondent in this Cause because it has entered into a Stipulation and Settlement Agreement ("Settlement") in its pending rate case, Cause No. 44967, which resolves all issues concerning the Tax Cuts and Jobs Act of 2017 to be addressed in this Cause. I&M also requests that administrative notice be taken of the Settlement and supporting testimony filed in Cause No. 44967. Alternatively, because the Settlement is currently under review by the Commission in Cause No. 44967, I&M requests that the requirements and directives of the Commission's February 16, 2018 Order be stayed with respect to I&M until the Motion to be Dismissed as a Respondent can be ruled upon.

No objections to the Motion were filed.

The Presiding Officers, having considered the Motion and the direct connection between the issues to be addressed in this Cause and the terms of the Settlement, grant I&M's request for administrative notice of the Settlement, a copy of which was attached to the Motion in accordance with 170 IAC 1-1.1-21(i), and stays the Commission's February 16, 2018 Order in this Cause with

respect to I&M pending a decision on I&M's Motion to be Dismissed as a Respondent subsequent to the disposition of the Settlement in Cause No. 44967.
