Dear Ms. Feiock,

After receiving your email, we double checked our records. To clarify, Duke Energy was notified of your appeal on May 24, 2017, the day you requested your appeal. The Consumer Affairs Division ("CAD") Director, Kenya McMillan, sent an email (attached) to the utility representative on your complaint, Ms. Melissa Coffman of Duke Energy. On June 1, 2017, Ms. Coffman requested a copy of the your appeal so she could send it to Duke Energy's legal counsel, and a copy of your appeal was sent via two emails (attached) that same day.

Because there is no attorney of record at the time of an appeal request, it is the utility representative that receives the notice and then, once the utility submits a Notice of Appearance in the docketed appeal, that attorney is added to the service list and is served with all future case documents.
