You are hereby notified that on this date the Indiana Utility Regulatory Commission has caused the following entry to be made:

On May 17, 2024, Petitioner Southern Indiana Gas and Electric Company d/b/a CenterPoint Energy Indiana South (“Petitioner”) filed Petitioner’s Submission of Agreed Settlement Procedural Schedule (“Submission”), submitting a proposed procedural schedule agreed to by all parties in this Cause. After reviewing the Submission, the Presiding Officers establish the following schedule for further proceedings in this Cause:

1. Settling Parties’ Settlement Prefiling. Petitioner, CenterPoint Energy Indiana South Industrial Group (“IG”), and SABIC Innovative Plastics Mt. Vernon (“SABIC”) (collectively, the “Settling Parties”) may prefile their settlement testimony and exhibits on or before May 22, 2024. Copies of same shall be served upon all parties of record.

2. **Non-Settling Parties' Prefiling.** All parties to this Cause other than the Settling Parties (the "Non-Settling Parties") shall prefile with the Commission the prepared testimony and exhibits constituting their respective cases-in-chief on or before July 19, 2024. Copies of same shall be served upon all parties of record.


3. **Settling Parties' Rebuttal Prefiling.** The Settling Parties shall prefile with the Commission their prepared rebuttal testimony, if any, on or before August 2, 2024. Copies of same shall be served upon all parties of record.

4. **Settlement Hearing.** The hearing scheduled for May 29, 2024 is continued to a settlement hearing that shall commence on September 3, 2024 at 9:30 a.m. in Room 222 of the PNC Center, 101 West Washington Street, Indianapolis, Indiana. September 10 and 11 have also been tentatively reserved for the settlement hearing, if necessary.


5. **Post-Hearing Filings.** The Settling Parties shall file their proposed order on or before September 25, 2024. The Non-Settling Parties shall file their respective proposed orders and/or any exceptions to the Settling Parties' proposed order on or before October 16, 2024. The Settling Parties shall file their reply to any other proposed orders, and the Non-Settling Parties shall file any cross-answering responses to the proposed orders of any party but the Settling Parties, on or before October 21, 2024.

6. **Ind. Code. § 8-1-2-42.7(e) Deadline Extension.** This schedule constitutes an extension of 126 days of the schedule established in our December 27, 2023 scheduling docket entry, with the original hearing date of April 30, 2024 continued to September 3, 2024. Therefore, pursuant to Ind. Code § 8-1-2-42.7(g), the 300-day deadline established by Ind. Code § 8-1-2-42.7(e) is extended by 126 days to February 3, 2025.
