MOTION TO WITHDRAW APPEARANCE

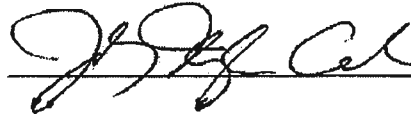

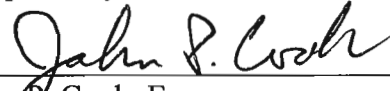

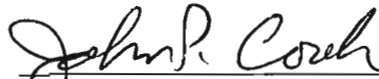
