Wabash Valley Power Association, Inc. dba Wabash Valley Power Alliance ("Wabash Valley") hereby submits this *Corrected Joint Notice of Agreed Two-Year Renewal of Settlement Agreement through September 12, 2022,* on its behalf and with the agreement of the Indiana Office of Utility Consumer Counselor ("OUCC") (collectively with Wabash Valley, the "Parties").

In the Indiana Utility Regulatory Commission's (the "Commission") September 12, 2018 Order in Cause No. 44455, the Commission approved the settlement agreement (the "Agreement") entered into by the Parties, and filed in this Cause, on July 16, 2018. Section 7 of the Agreement provides as follows:

<u>Renewal</u>. Any joint notice of agreed renewal of this Agreement shall be filed at least thirty (30) days before the expiration of the then-current 2-year term, effective immediately following the end of the previous 2-year term, without further order from the Commission, unless otherwise ordered by the Commission, after notice and hearing. Future renewals of this Settlement Agreement shall be subject to termination by the Commission, after notice and hearing.
