SUBMISSION OF 2023 ANNUAL REPORT IN CAUSE NO. 43566**

Respondent, Southern Indiana Gas and Electric Company d/b/a CenterPoint Energy Indiana South ("CEI South") (formerly "d/b/a Vectren Energy Delivery of Indiana Inc.") submits its 2022 Annual Report in compliance with the Indiana Utility Regulatory Commission's ("Commission") Final Order in Cause No. 43566 ("Order"). In the Order, the Commission required all Indiana regulated utilities to file an annual report in this Cause by March 15 and include the following information:

- 1. The number and size of customers participating in the utility's RTO demand response tariff(s) or rider(s).**

Response: CEI South had no participation for 2022 in its Midcontinent Independent System Operator ("MISO") Demand Response ("DR") Rider ("Rider DR").

2. **The particular RTO demand response program or provision in which customers are participating and the amount of load participating.**

Response: Not applicable. CEI South had no participation for calendar year 2022 in its Rider DR.

3. **A description of the efforts being made to encourage participation by small and medium sized customers in the RTO demand response tariff(s) or rider(s).**

Response: CEI South maintains a published one-page DR information sheet on its website that provides information to electric customers regarding DR programs in which they may be eligible to participate. In addition, CEI South employees may participate in on-site meetings with customers to explain the applicability and/or opportunities for participation.


4. **Any agreements reached, or being considered, with any Curtailment Service Providers (“CSP”) or other entity for the purpose of aggregating customers for participation in RTO demand response programs or provisions.**

Response: CEI South did not reach or consider any Curtailment Service Providers (“CSP”) agreements in 2022.

5. **Information on how the RTO demand response tariff(s) or rider(s) were used by the utility in meeting its service obligations, which RTO products the demand response capabilities made possible by the tariff(s) or rider(s) were employed by the utility, when the demand response resources were used by the RTO and the circumstances existing at that time for both the utility and the RTO.**

Response: Not applicable. CEI South had no participation for calendar year 2022 in its Rider DR.


