SUBMISSION OF DEMAND RESPONSE ANNUAL REPORT**

Respondent, Indianapolis Power & Light Company ("IPL"), by counsel, hereby submits its Demand Response Annual Report in compliance with the Indiana Utility Regulatory Commission's ("Commission") Order in this Cause dated July 28, 2010 ("Generic Order").

IPL's Rider No. 23, Market Based Demand Response ("Rider 23") authorizes qualifying IPL customers to participate in the Midcontinent Independent Transmission System Operator, Inc.'s ("MISO") Emergency Demand Response and Demand Response Resource Type 1 programs through IPL. Rider 23 was approved by the Commission's March 2, 2011 Order in Cause No. 43566-MISO2 (the "Rider Order"). In compliance with the Rider Order, IPL tendered Rider 23 on March 4, 2011 to the Commission's Electricity Division and Rider 23 became effective on March 7, 2011.


