Case Description: For the year 2025 the Indiana Utility Regulatory Commission approved an 11% rate increase for Duke Energy. Duke Energy has gone way above that approved rate increase. Duke Energy a few years ago stopped putting the cost per kilowatt for their total electric charges. The purpose of this was to intentionally screw over their customers thinking that we will not catch price increases and that we're inept to figure TOTAL cost per kilowatt. Those of us like me who excelled in math in high school & college know how to figure it out. In the 12 months prior to Duke raising their rates my cost per kilowatt averaged 13 cents a kilowatt. February's bill received in March 2025 was 1816 kilowatts was \$255.90 which was 13 cents a

kilowatt minus taxes & lightning strike charge. Now an 11% increase on a yearly average would be 14.5 cents a kilowatt MAXIMUM allowed by the IURC. After the increased allowed by the IURC my April bill for March was 996 kilowatts for \$186.71 at 17.2 cents a kilowatt. THIS IS A 24.4% INCREASE WAY ABOVE 11% ALLOWED!!! Then comes May bill for April; 797 kw at \$156.33 for 18 cents per kw AN INCREASE OF 27.8% AGAIN WAY ABOVE THE 11% INCREASE ALLOWED BY IURC!!! Then comes June's bill for May; 637 total used kw for \$132.15 for 19 cents a kilowatt for A 31.5% INCREASE ABOVE THE ALLOWABLE 11% INCREASE!!! Now on June 6, I contacted Olivia of IURC via phone & was told to contact Duke first. So I contacted them via phone & filed a complaint. When done I was told I would be contacted by phone or email in 24 to 48 hours. I gave them the benefit of the doubt for the weekend. Here it is Wednesday with no phone calls or email. So I filed a complaint on their website Tuesday. I immediately received an email that stated this complaint has already been phoned in. THAT'S IT & NOW IT'S WAY PAST 24 TO 48 HOURS WHICH TELLS ME DUKE WILL CONTINUE TO DEFY ITS CUSTOMERS & THE STATE OF INDIANA!!!! Now I expected to hear the excuse from them and you that the more electricity you use the cheaper the kilowatt. THIS HAS NOT BEEN THE PRACTICE OF THE PAST. The lady I talked to said this should have been explained in a letter from Duke before rates were raised. I told her I've been living here for 18 years & Duke Energy HAS NEVER EVER SENT ME A RATE INCREASE LETTER. If I am not satisfied and this is not straightened out by the IURC I am prepared to notify the FBI, FTC, BBB, PLUS seek an attorney in Indianapolis who does class action lawsuits which means the IURC may be investigated for collusion & possible bribery charges. Duke Energy is a greedy company that is totally out of control!!!!!! I have a neighbor behind me that has budget billing. There was a note in his last bill that stated after his year is up for budget billing his rates will increase 11%. Now they never warn me in my bills that rates are going up. I heard it on channel 13 news Indy. I told Duke they are penalizing me for not doing budget billing & making up for it.
