CHANGE IN RATES AND  
CHARGES BY THE CITY OF  
AUBURN WATER AND ELECTRIC  
UTILITIES

DeKalb County, Indiana

Notice is hereby given that City of  
Auburn Water and Electric Utilities,  
DeKalb County, Indiana, under and  
pursuant to the Public Service  
Commission Act, as amended, in-  
tends to file with the Indiana Utility  
Regulatory Commission ("IURC") on  
or about April 29, 2022 a decrease in  
the schedule of rates and charges to  
reflect the recent removal of utility  
receipts tax in the calculation of rates  
and charges pursuant to HEA 1002.  
The decrease in these rates and  
charges is applicable to all custom-  
ers. This decrease in rates and  
charges results in a \$0.39 reduction  
in the average residential monthly  
water bill assuming 4,000 gallons and  
a \$0.76 reduction in the average  
residential monthly electric bill as-  
suming 700 kWh.

The changes in schedules of rates  
submitted to the Commission are  
based solely upon HEA 1002,  
recently passed by the State legisla-  
ture. The decrease to rates and  
charges shall apply following final  
approval by the Commission or July  
1, 2022, whichever is later.
