You are hereby notified that on this date the Indiana Utility Regulatory Commission ("Commission") has caused the following entry to be made:

On October 6, 2020, petitioner Southern Indiana Gas and Electric Company d/b/a/ Vectren Energy Delivery of Indiana, Inc. ("Vectren South"), by counsel and on behalf of Vectren South, the Indiana Office of Utility Consumer Counselor, and Citizens Action Coalition of Indiana, Inc. (collectively, the "Settling Parties"), filed *Joint Notice of Settlement in Principle and a Motion to Continue Procedural Schedule* ("Joint Motion"). In the Joint Motion, the Settling Parties notify the Commission that they have reached a settlement in principle in the above-captioned Cause and request the evidentiary hearing scheduled in this matter for October 8, 2020, be continued and converted to a settlement hearing on or about November 6, 2020. The Settling Parties further advise that they plan to file testimony and exhibits supporting the settlement no later than October 20, 2020, and an agreed proposed order will be filed on or about the date of the settlement hearing, with no other post hearing briefing now being necessary.

Having reviewed the Joint Motion, the Presiding Officers find:

1. The date within which to file the Settling Parties' settlement agreement and supporting testimony and exhibits in this Cause is extended to on or before October 20, 2020.

2. The evidentiary hearing in this Cause shall be converted to a settlement hearing and is continued from Thursday, October 8, 2020, at 9:30 a.m. to 9:30 a.m. on November 12, 2020, in Hearing Room 224 of the PNC Center, 101 West Washington Street, Indianapolis, Indiana, at which time the Settling Parties will be stipulating to the admission of prefiled evidence and waiving cross-examination, consistent with the Joint Motion and informal communications with the Presiding Administrative Law Judge, subject to witness questions the Commission may have. The witnesses for whom the Commission has questions, if any, shall appear at the settlement hearing for Commission questions if deemed necessary. If the Commission has no questions for the Settling Parties' witnesses, the settlement hearing may be conducted via a WebEx video and audio hearing.

3. In lieu of the schedule for proposed orders and exceptions being established before the conclusion of the evidentiary hearing, as set forth in the docket entry issued on July 10, 2020, the Settling Parties shall submit an agreed proposed order on or before November 12, 2020, with no additional post hearing briefing or exceptions now contemplated.
