IUSF OVERSIGHT COMMITTEE REPORT TO THE COMMISSION

The Indiana Universal Service Fund ("IUSF") Oversight Committee ("OC") respectfully submits the May 2008 IUSF status report to the Indiana Utility Regulatory Commission ("IURC" or "Commission") for its consideration. Solix, Inc., the Independent Third-Party Administrator of the IUSF prepared the report in accordance with the Statement of Work contained in part II of the Request for Proposal ("RFP") submitted by the OC on August 3, 2007 and approved by the Commission on September 4, 2007.

On June 25, 2008, Solix prepared the attached IUSF Monthly Status Report and provided it to the Commission Staff and all OC members. The report provides a Statement of Fund Performance, based on accrual accounting and a Cash Flow Analysis, based on cash accounting.

The OC has reviewed Solix's report and believes that Solix has prepared a thorough and completely satisfactory status report on the financial condition of the IUSF. In addition, Solix's presentation of financial information on both an accrual accounting and cash accounting basis provides a complete picture of the status of the IUSF.
