Allen Mounts Request to the Utility Board Approval

Re: Extending shut-off moratorium, suspension of various fees and extended payment arrangement.

**Board Meeting: 07-07-2020** 

On March 17, the Utility Board approved a moratorium on shutoffs. That moratorium was to remain in effect until the Utility Board determined that the risk levels associated with COVID 19 have lessened.

The moratorium remains in place and we do not need action to further to extend the moratorium.

On June 29<sup>th</sup>, the Indiana Utility Regulatory Commission issued Order 45377 prohibiting jurisdictional utilities from shutting off Utility service connections through August 14<sup>th</sup> and to refrain from collecting certain utility such as deposits, late fees and reconnection fees. The IURC also directed jurisdictional facilities to offer more flexible payments plans of at least 6 months. Finally, the IURC Order also urged all non-jurisdictional utilities to comply with the terms of the IURC Order.

The IURC Order was followed by the Governor's Executive Order 20-33 issued the following day on June 30 which recognized the IURC Order and which strongly urged all non-jurisdictional utilities in the state to follow the guidance of the IURC as set forth above regarding utility shut offs, fees and payment plans until August 14<sup>th</sup>.

After review with legal counsel, we believe the Evansville Water and Sewer Utility is NOT an IURC "jurisdictional utility" and that we are not bound by the IURC order. However, we believe we should follow the plea of the IURC and the Governor.

It is clear that the IURC Order and the Executive Order 20-33 has asked utilities like the EWSU to extend the moratorium for "no shut-offs" until August 14<sup>th</sup>. Today, we are requesting that Utility the Board affirms continuance of the previously board approved No Shut-off moratorium.

In addition, EWSU management is requesting that Utility Board authorizes management to:

- 1. Continue to refrain from collecting certain utility fees (defined as: late fees, convenience fees, deposits and reconnection fees).
- 2. Extending payment terms of at least six months for all delinquent customers.

Extending payment terms beyond six months but no more than twelve months for extenuating circumstances. For example, an unusually large water bill that resulted from a water leak that does not qualify for a leak adjustment per EWSU policy.

#### Evansville organizations prepare for lift of moratorium

EVANSVILLE, Ind. (WEHT)- During his daily briefing Wednesday, Indiana Governor Eric Holcomb says he plans to extend the moratorium on evictions through July. But the moratorium on utility shutoffs is still under consideration.

Local organizations have been working to figure out how many people will be impacted when the moratoriums are lifted.

The extension of the moratorium puts organizations like Aurora in a better position to gather money to help.

"It is my understanding that a ballpark number that we have heard has been approximately 2500 or more," Zac Heronemus says.

Allen Mounts with the Evansville Water and Sewer Utility says they have identified the number of people at risk, "there are a little over 2000 people that are at risk of shut off."

Just a fraction of the people the Evansville water and sewer utility company serves.

"We have about 63,000 metered customers. About 95% of those are residential customers," Mounts explains.

Aurora is one of the organizations trying to keep people in their homes.

Zac Heronemus, the executive director, tells us they've received grant money from various resources. Specifically, from the Department of Metropolitan Development.

"About \$\$349,000. Most of that which would be provided for rental and utility assistance for those individuals, those individuals, those families that have been affected by COVID, and do you need that rental and utility assistance." He says they're working to secure more and expect the total to be around one point seven million dollars. Heronemus tells us they estimate around 2500 families need assistance but right now there's just not enough money to help them all. They're working to change that.

"We're thinking that at minimum and it could be low approximately \$3200-\$3500 per family that has been negatively impacted," Heronemus says. "\$1.7 million is approximately about 550 families that we would be able to help."

Holcomb also announced the start of a rent assistance program for those impacted by COVID-19. The program will provide up to \$500 per month for households unable to pay rent due to the pandemic.

#### Utility commission extends pause on disconnections another 45 days because of COVID-19

EVANSVILLE, Ind. — Citing the continuing statewide impact of COVID-19, the Indiana Utility Regulatory Commission on Monday extended the moratorium on customer disconnections another 45 days.

Gov. Eric Holcomb's executive order pausing service disconnections because of the economic impact of the pandemic was set to expire at the end of July 1.

The commission's order extends the deadline through Aug. 14.

This may be good news for area residents who have fallen behind on utility bills after losing employment because of Indiana's stay-at-home order, which was meant to slow the spread of the novel coronavirus causing COVID-19. Those restrictions began in mid-March and are set to expire July 4.

"We have seen a tremendous increase in people seeking energy assistance since it (COVID-19) began," said Cynthia Balde, who administers the energy assistance program for the Community Action Program of Evansville.

Vectren plan emphasizes solar, wind power but keeps some coal, natural gas

From February through April, Vectren experienced an 85 percent increase in the number of its customers 60 days or more behind on paying their energy bills, said Natalie Hedde, a Vectren spokeswoman.

At the same time, there was a 6 percent reduction in payment transactions, Hedde said, indicating an increase in customers who made no payments at all.

The number of utility disconnection notices sent out every month by the Evansville Water & Sewer Utility has nearly tripled. Director Allen Mounts said it has increased from about 800 to 2,300 a month.

Both Vectren and EWSU have temporarily halted disconnections during the pandemic crisis.

Hedde noted that Vectren suspended disconnections in March before the governor's order and even reconnected some customers who had recently been shut off. The utility has been encouraging customers to practice energy conservation to help keep bills lower and has worked with individual customers to find assistance and make payment plans — so that when the moratorium does end, customers are not suddenly scrambling to pay huge bills.

"We are proactively communicating with customers through outbound call campaigns, email, social media and bill messaging to ensure customers know how to take advantage of the multiple assistance options," she said. "We will continue partnering with our customers on an individual basis now and when the moratorium is lifted, regardless of when that ultimate date will be."

She said because individual financial circumstance may vary, it is important for customers to contact Vectren to work out which assistance options may be the best fit, whether it is Energy Assistance funding or township trustee assistance or other help.

Monday's order from the utility commission also denied a request by some Indiana utility companies, including Vectren, to adjust their rates to recover lost revenue from the pandemic.

Although Vectren was among the utilities petitioning the IURC for authority to seek recovery of lost revenues due to COVID-19, Hedde said the energy company never intended to do so.

"Vectren was not going to pursue it even if it would have been allowed," she said.

The EWSU also has been working with customers to arrange payment plans, allowing payments to be spread out over three months, Mounts said, and also find financial assistance.

The moratorium applies to all customers of state-regulated utilities, including water and sewer as well as electric and natural gas companies, said Stephanie Hodgin, IURC spokeswoman.

However, while the commission regulates Evansville Water & Sewer rates, customer service rules and regulations, which includes service disconnections, are not part of the IURC's jurisdiction, Hodgin said. But she said the commission's order encourages all utilities to consider implementing the practices in the order, given the statewide impact of COVID-19.

Mounts said he will recommend the utility board approve the changes necessary to follow the IURC's guidance and continue suspending disconnections.

One source of financial help for water customers comes from funding provided through EWSU's contract with Home Serve — a for-profit company which sells water and sewer line protection plans.

Evansville Water & Sewer receives 10 percent of the Home Serve profits, Mounts said, and puts it all into funding to provide assistance to low-income customers. He said EWSU has been able to set aside more than \$100,000 for such help so far this year. One source of help for energy bills is the Community Action Program of Evansville (CAPE), which distributes state energy assistance funding to Vanderburgh, Posey and Gibson county residents based on household income.

CAPE also is distributing gas and electric bill assistance funds received through the federal CARES Act, which was passed in March to ease the economic downtown caused by the pandemic.

Evansville Water & Sewer Utility extends no-shutoff period through Aug. 14

The Evansville Water & Sewer Utility board affirmed Tuesday it will comply with state directives to not disconnect any customers until Aug. 14.

The moratorium was put in place in mid-March, as the coronavirus pandemic took root and job losses mounted.

Indiana Gov. Eric Holcomb's original order pausing shutoffs expired July 1; the Indiana Utility Regulatory Commission recently extended it another 45 days.

Evansville's utility isn't necessarily bound by that order, but the board on Tuesday agreed with Director Allen Mounts request to keep the moratorium in place through Aug. 14. The vote was 5-0.

Additionally, the EWSU will follow state guidance in offering delinquent customers flexible payment plans of up to 6 months. For extenuating circumstances, such an unusually large bill caused by a leak, payment plans may stretch to a year.
