SUBMISSION OF AGREED PROCEDURAL SCHEDULE

Duke Energy Indiana, LLC (“Duke Energy Indiana”), by counsel, respectfully submits the following Agreed Procedural Schedule on behalf of Duke Energy Indiana and the Indiana Office of Utility Consumer Counselor (“OUCC”) (together, the “Parties”), and requests the Commission approve this procedural schedule. In support of this schedule, Duke Energy Indiana provides the following:

1. Duke Energy Indiana filed its Verified Petition, case-in-chief testimony and non-confidential exhibits on June 22, 2020.

2. Since that time, the Parties¹ have reached an agreement on a procedural schedule as outlined below:

- September 16, 2020: OUCC/Intervenor pre-filed testimony
- September 30, 2020: Duke Energy Indiana Rebuttal Testimony/cross
answering

Week of October 26, 2020: Evidentiary Hearing

¹ Duke Energy Indiana notes that the Citizens Action Coalition of Indiana, Inc. has been consulted and is in agreement with the proposed schedule should the Commission ultimately grant its pending intervention.

3. The Parties have agreed that any response or objection to a discovery request shall be made within ten (10) calendar days of the receipt of such request. Any discovery requests served after September 30, 2020, shall be responded to or objected to within five (5) business days.

4. The Parties agree to electronic service of discovery and filings to all parties in this proceeding.

5. Counsel for Duke Energy Indiana has conferred with counsel for the OUCC, who has indicated their agreement with the procedural schedule presented herein and the filing of this submission.

WHEREFORE, Duke Energy Indiana, on behalf of itself and the OUCC, requests that the Commission establish a procedural schedule consistent with this Submission via Docket Entry.
