# OUCC'S WITHDRAWAL OF OBJECTION TO TRUE UP REPORT AND REVISED TARIFF

On July 25, 2022, the Indiana Office of Utility Consumer Counselor ("OUCC") objected to the City of Bloomington, Indiana's ("Bloomington") True Up Report and Revised Tariff. On July 27, 2022 Bloomington filed its response to the Objection in which, without acknowledging that its true-up report was objectionable, it promised it would accomplish three of the steps the OUCC requested Bloomington take and represented through counsel that any increase in debt service resulting from the \$90,844 in excess borrowing would not affect metered rates resulting in no need for a refund. In its Objection, the OUCC did not recommend that the level of rates indicated by the tariff should be rejected. Based on Bloomington's representations and commitments in its response including its desire to avoid the administrative cost revising its tariff twice while this matter is pending, the OUCC hereby withdraws its objection without prejudice so that Bloomington may secure the administrative efficiencies by issuing one revised tariff.

WHEREFORE, the Indiana Office of Utility Consumer Counselor respectfully withdraws its Objection to Debt True Up Report so that the Indiana Utility Regulatory Commission may approve without further delay Bloomington's revised tariff as filed on July 11, 2022.
