Petitioner's Exhibit 2, Direct Testimony of F. Shane Bradford

- Page 6, lines 10 to 11 – change the answer on those lines to: “While the All-Source RFP Process and negotiations occurred before I assumed my current position, I reviewed and confirmed the All-Source RFP process, the evaluation of proposals, and the selection and commercial negotiation of the top two projects, which are the subject of this filing.”
- Page 23, lines 16 to 18 – change the answer on those lines to: “While the Levelized Rate was determined before I assumed my current position, I reviewed and confirmed that the proposed Levelized Rate of \$0.0535 per kWh of energy produced by the Posey County Solar Project is competitive with the rates that would be available under PPAs.”
