NOTICE OF INTENT TO MAINTAIN CURRENT FACTORS

I&M hereby notifies the Indiana Utility Regulatory Commission (Commission) that, due to the de minimis estimated change in Solar Power Rider (SPR) factors that would result from reconciling I&M's SPR factors at this time (an approximate five cents adjustment for a typical residential customer using 1,000 kWh per month), as well as the unnecessary administrative burden that would accompany such SPR filing, I&M intends to continue in effect the SPR factors approved by the Commission's March 29, 2021 Order in this Cause until new factors are approved in I&M's subsequent Cause No. 45245 SPR-2 filing. I&M anticipates filing its ensuing SPR-2 in early-2023, to include reconciliation of the SPR factors.

I&M further updates the Commission that the St. Joseph Solar Farm (SJSF) was placed in-service on March 31, 2021. This is consistent with the expected March 2021 in-service date provided in the SPR-1 testimonies of I&M witnesses Brent E. Auer (p. 4) and Joseph G. DeRuntz (p. 6) and consistent with the Commission's Cause No. 45245 Order dated February 19, 2020, p. 15, Ordering Paragraph No. 11, which required the SJSF to be placed in-service before January 1, 2024.

I&M has had discussions with the Indiana Office of Utility Consumer Counselor (OUCC) and the OUCC has no objection to continuing the SPR factors as discussed above.
