SUBMISSION OF AGREED PROCEDURAL SCHEDULE
IN LIEU OF PREHEARING CONFERENCE

Lightstone Generation LLC and Lawrenceburg Power, LLC, on behalf of itself and Joint Petitioner AEP Generation ("AEG") and the Indiana Office of Utility Consumer Counselor ("OUCC"), by counsel, respectfully submit this agreed proposed procedural schedule in lieu of a prehearing conference and preliminary hearing in accordance with 170 IAC 1-1.1-15(e). The parties have agreed to the following terms:

1. **Joint Petitioners Prefiling Date.** Joint Petitioners prefiled the direct testimony and attachments constituting their respective cases-in-chief on October 12, 2016.
2. **OUCC and Intervenors Prefiling Date.** The OUCC and any intervenors will prefile the direct testimony and attachments constituting their respective cases-in-chief on or before November 16, 2016.
3. **Joint Petitioners Rebuttal Prefiling Date.** Joint Petitioners will prefile any rebuttal evidence on or before November 23, 2016.
4. **Evidentiary Hearing.** The parties request that the Commission set an evidentiary hearing in this Cause during the week of December 5, 2016.
5. **Discovery.** Discovery is available for all parties on an informal basis. Any response or objection to a discovery request shall be made within seven (7) calendar

days of the receipt of such request. The parties to conduct discovery using electronic means.

6. **Service.** The parties agree that service will be made via electronic mail or other same-day delivery.

Counsel for Lightstone Generation and Lawrenceburg Power has consulted with counsel for AEG and the OUCC and is authorized to represent that all parties agree to the above schedule.
