UNOPPOSED MOTION TO MODIFY PROCEDURAL SCHEDULE

American Suburban Utilities, Inc. ("ASU"), by counsel, has conferred with the Office of Utility Consumer Counselor ("OUCC") and as a result of those discussions now proposes a modification of the procedural schedule, which will promote the administrative efficiency of this Cause. ASU has filed its certificate that the improvements are in service; however, not all construction work has been completed yet. Due to circumstances beyond its control and related to the current COVID-19 pandemic, ASU has been unable to complete the remaining construction work by June 30, 2020. ASU proposes to extend the date established in the Indiana Utility Regulatory Commission's ("IURC") docket entry dated March 4, 2020, for the OUCC and any intervenors to submit their prepared testimony until after September 30, 2020 when the work on the Phase III improvements are to be completed pursuant to the further extension of the IDEM construction permit. ASU requests that the procedural schedule be modified as follows:

1. On or before September 30, 2020, ASU will file notification that all construction activities have been completed and provide to the OUCC the final inspection reports from TBird Engineering, final completion certificate and notification that final payment has been made, Certified Record Documents as submitted to IDEM's Facility Construction and Engineering Support Section, and the application for renewal of the NPDES Permit as submitted to IDEM NPDES Permit Section.

2. The OUCC and any intervenors will file the testimony and evidence constituting

their respective objections, if any, to the Phase III rates on or before November 18, 2020.

3. ASU will file its responsive testimony on or before December 18, 2020.

4. The evidentiary hearing will be rescheduled to begin January 20, 2021 or as soon

thereafter as possible.

5. During the extension, interim rates subject to refund will remain in effect as

previously approved, until the ultimate effective date of the Phase III rates is addressed in this

subdocket.

6. Discovery up until the date that ASU files its Notice of Completion shall be

responded to within ten (10) business days of receipt. Upon the filing of Petitioner's Notice of

Completion, discovery turnaround shall return to five (5) business days. Discovery served after

noon on a Friday or day before a day on which the Commission offices are closed will be deemed

received the following business day.

7. ASU has consulted with the OUCC, who has indicated its agreement to the

procedural schedule and discovery terms proposed herein as well as continuation of interim rates

subject to refund.
