A 56.70% sudden increase across the board (water and sewage) is way out of line.

The city of Connersville had a 5% increase but that includes water sewage and trash. Trash isn't included with our utilities in Pleasantview. If you want trash pickup in Pleasantview you have to go through a separate company.

Matt Shreck has falsely accused us of being late on our utility bill three different times since we moved here in 10-2015. I had to make a copy of the front and back of my personal checks and mail to him for proof that our bills had been paid in full and on time each time. As time has gone by I have found out that several senior citizens in Pleasantview have also received past due notices. Everyone I talked to, (all senior citizens) do not have a printer to print out a copy of their checks to prove that their bill was paid in time, so they would pay the bill again with penalties. I know it is the individual customer's responsibly to prove that their bill was paid on time but it sure seems odd that so many people in Pleasantview are hit with late notices on a regular bases.

Matt had our driveway dug up to fix a water leak that covered the meter. It took over 6 months to have the 6x3 ft hole refilled with concrete. I had to continuously call Matt and finally went to his office at the Health Department to get the job done. That is unacceptable. One last complaint. We have very low water pressure.
