# TESTIMONY OF OUCC WITNESS KRISTEN WILLOUGHBY CAUSE NO. 45484 EAST SHORE CORP.

# I. <u>INTRODUCTION</u>

1	Q:	Please state your name and business address.
2	A:	My name is Kristen Willoughby, and my business address is 115 West Washington
3		Street, Suite 1500 South, Indianapolis, Indiana 46204.
4	Q:	By whom are you employed and in what capacity?
5	A:	I am employed by the Indiana Office of Utility Consumer Counselor ("OUCC") as
6		a Utility Analyst in the Water/Wastewater Division. My qualifications and
7		experience are set forth in Appendix A.
8	Q:	What relief has Petitioner requested?
9	A:	East Shore Corp. ("East Shore" or "Petitioner") seeks authority to transfer its
10		franchise, works or system to East Shore Conservancy District ("East Shore
11		Conservancy") and surrender its certificates of territorial authority ("CTAs").
12	Q:	What is the purpose of your testimony?
13	A:	I discuss East Shore's basic characteristics and provide a brief history of the utility.
14		I recommend approval of the transfer of its franchise, works or system from East
15		Shore to East Shore Conservancy and the surrender of the East Shore CTAs.
16	Q:	What did you do to prepare your testimony?
17	A:	I reviewed East Shore's case-in-chief filed on January 22, 2020, which include the
18		testimonies of William Steck, member of the Board of Directors and President of
19		East Shore Corp. and James Bremner, member of the Board of Directors and the
20		Treasurer and Financial Clerk of East Shore Conservancy District. I reviewed the
21		Indiana Utility Regulatory Commission's ("Commission" or "IURC") final orders

in Cause Nos. 41494 and 42667 in which Petitioner was granted its original CTA and expanded CTA, respectively.

## II. EAST SHORE CHARACTERISTICS AND ASSETS

## Q: Please describe East Shore's characteristics.

A:

East Shore is a not-for-profit corporation which owns and operates a wastewater utility in Marshal County. The East Shore System has 108 members, 102 of which currently receive sewer service. (Six members joined the utility when it was formed but have not yet connected.) The wastewater system began operating in 2001 using a wetlands drip field system and has approximately 13,760 feet of force main. Each home has a grinder pump and lateral owned by the property holder which connects to the system. The wetlands drip field takes up 10 acres on a 12-acre parcel Petitioner owns. The homes served by the system are on wells with high iron content. Over time, the high iron content of the water has proven to be an issue for the wetlands drip field system as it clogs the emitters. <sup>1</sup>

# Q: Has Petitioner had any compliance issues?

15 A: Yes. On August 1· 2019, East Shore received a cease-and-desist letter from the
16 Marshal County Department of Health. This letter stated the "system is deemed in
17 failure in accordance with 410 IAC 6-10.1-9(3) effluent is discharged from the
18 system contaminating surface waters."<sup>2</sup>

## Q: Did Petitioner address the compliance issue?

20 A: Yes. East Shore first explored the option of fixing the wetlands drip field system
21 but learned that option required more land than what East Shore possessed. The

additional land it needed was not available. Therefore, East Shore constructed a force main to the Town of Culver, which was completed and placed into service on July 16, 2020.<sup>3</sup> On September 3, 2020, the Marshal County Department of Health sent East Shore a letter acknowledging that East Shore had properly abandoned the old wetland drip field.<sup>4</sup>

# III. PROPOSED TRANSFER

6 O: Why is East Shore transferring the utility to the East Shore Conservancy 7 **District?** 8 A: East Shore's long-term goal was to get out of the wastewater treatment business 9 and to have all property owners along the east shore of Lake Maxinkuckee connect 10 to the sewer. Petitioner believes this sale will ultimately achieve these two goals. 11 The freeholders along the east shore of Lake Maxinkuckee who are not connected 12 to the sewer are located in the East Shore Conservancy's area.<sup>5</sup> Additionally, East 13 Shore believes East Shore Conservancy is "in a better position to provide sewer 14 service because it has access to credit and advantageous financing that East Shore 15 does not have and has the ability to spread its operational costs over a greater 16 number of customers and achieve a greater overall positive environmental impact."6 17

# Q: Please describe East Shore Conservancy's characteristics.

19 A: The East Shore Conservancy District was formed on June 15, 2020. The East Shore 20 Conservancy will serve 130 freeholders, including all 108 members of East Shore.

1 Some of the board members of East Shore serve on the board of the East Shore 2 Conservancy District. This continuity will preserve institutional knowledge. 3 Q: What assets are the East Shore Conservancy District acquiring? 4 A: The East Shore Conservancy is acquiring all of East Shore's assets comprising 12 5 acres of land where the old wetland drip field is located and all force mains 6 including the recently constructed force main to the Town of Culver. 7 What is the purchase price for the East Shore assets? Q: 8 A: The purchase price will be the "outstanding debt plus the current liabilities less cash on hand, not including normal and customary monthly operational expenses."8 All 9 10 assets that do not have outstanding debt associated with them are being sold at \$0 11 to keep rates low and prevent current members from paying for the assets twice in 12 rates. The Option to Purchase lists the agreed upon price as not more than \$1,875,000.9 13 14 Q: Will East Shore Conservancy charge the same rates as East Shore? 15 A: No. East Shore Conservancy will change the rate structure from \$100 per month to 16 a fee ranging from \$85 - \$120 per month depending on the number of bathrooms in 17 the home. 18 Q: Do you believe the transfer of East Shore's franchise, works or system to East 19 Shore Conservancy is in the public interest? 20 A: Yes. East Shore Conservancy is primarily made up of existing East Shore members 21 and its board shares some of the same members as East Shore. The primary 22 difference between the two entities is the corporate structure. This change in

- 1 corporate structure will potentially allow East Shore Conservancy to finance the 2 debts East Shore currently holds at a lower interest rate through the Indiana Finance 3 Authority.
- 4 Q: Do you have any concerns about the proposed transfer?
- 5 A: No. I am not aware of any reason the transfer should not be approved.

# IV. OUCC RECOMMENDATIONS

- 6 **Q:** What are your recommendations?
- 7 A: I recommend that the Commission approve Petitioners' request for approval of the
- 8 transfer and sale of East Shore's franchise, works or system to East Shore
- 9 Conservancy and the surrender of East Shore's certificates of territorial authority.

A:
