My name is Reynaldo Hernandez. I live here in South Bend. I wish to comment against the proposed I & M electric rate increase. I speak also on behalf of my wife, J GlendaRae Hernandez.

This proposed increase is going to hit hard on seniors and others on fixed incomes, such as myself. Yes, the cost of everything is going up, and according to this morning's paper rates have increased only 3% over the last 10 years, adjusted for inflation. The proposed increase well exceeds that rate of increase. If there is any rate increase at all, it should either be adjusted for seniors of otherwise slimmed to ease the impact on all. Such provisions are made for real estate taxes, and should be made for electric rates as well.

The increase would be more tolerable if I & M were acting more assertively to convert from reliance on coal to wind and solar. Yes, a new solar plant is now going up to our immediate west, and I have been able to modify my electric supply so that half of it comes from solar sources without increasing my rate. The downside is that when last year I & M fought hard against the Clean Power Plan and "updated" their Rockport plant instead of replacing it with solar at similar, even less, cost. And don't give me that crap about saving Indiana coal jobs. Rockport burns out of state coal. I highly resent having to pay more for keeping us in prison to the past.

The term "public utility" implies that it exists to serve, not exploit. The proposed rate increase exploits.

In sum, I & M needs to be more responsible in respecting both the financial limitations of lower income Hoosiers and an environment badly in need of reducing carbon emissions. In light of both, please reject or limit the increase.

Underscoring the fact that many jobs in Indiana do not pay enough to allow families to afford the most basic

household budget.

The core issue is that these jobs do not pay enough to afford the basics of housing, utilities, child care, food, healthcare and transportation.
