I am writing your office to express my extreme opposition to the proposed rate increase for water utility from the City of Anderson, Indiana. An approval of any increase in water delivery cost is asinine. The same Administration and City Council petitioned for a base rate increase in 2006 that was approved. They cited much needed maintenance as the reason. We as the residents have not seen the maintenance promised to the system. This rate increase cites the same needs for the increase. Lip service is cheap.

It is through years of mismanagement and lack of vision that is causing the city to ask for the increase. The appointment of unqualified management personnel, along with their inability to manage a budget should not fall upon the customer. This request comes on the foot heels of three (3) recent approvals by the City Council that validate mismanagement, lack of vision and poor resource management by the City Administration.

First, an electric rate increase in 2013 of 7.8% on the base cost of electric delivery to the residential user. All be it not water, nonetheless an approved increase cited for maintenance. As a community we've seen no increase in maintenance and an increase in the time it takes for electric service calls to be rectified. Certain areas of the City have regularly occurring power outages; my neighborhood being one of them.

Second, a \$21,000/year pay increase to Water Superintendent Torn Brewer in February 2014. This was approved by the City Council after Mr Brewer threatened to quit, leaving the City without a certified staff member. It would behave the City to start the process of certifying additional staff. Pay raises like the one given to Mr Brewer are appalling and validate lack of leadership and resource management.

Third, and the most costly was the \$21 million decision by the same City Administration and City Council in 2006 to eliminate water meter reading personnel and install automatic satellite read water meters. In early 2014 the City started the replacement process of these meters because of a high failure and misreading rate. A \$21 million mistake that we as customers did not ask for.

Each of these examples show the City's inability to effectively manage revenues and costs associated with the management of our public utilities. I again oppose the increase. The City needs to prove effective business leadership and appointment of management personnel who are able to manage available resources.

Consumer Services Staff:

As concerned residents of Anderson we have seen and are paying higher, electric, gas, automobile gasoline, and grocery prices. Where does it end? Now, water rate hikes.

Anderson has suffered industry loses and is not recovering very fast. It is a city of senior citizens, mostly retirees of General Motors. We do not get promotions, pay increases, or the occasional bonuses. Once in a while we get a cost of living increase and that is when we see an increase in prices, especially Medicare. The industries in Anderson are hospitals, assisted living, senior housing, nursing homes, and occasionally in the Flagship there will be a factory added. The big industry in Anderson right now is Nestles. Most seniors are really not wanting to go back to work, but if things keep getting worse, we will have to. There are not many jobs for seniors these days, due to health conditions a lot of us are limited on what we can do.

We understand that things wear out and need replacement. As home owners we are constantly replacing worn out items (roof, electric, appliances, etc.). We also have to replace our automobiles every so often.

Our question is with the water rate hike over two years, why are you taking out a 14.3 million dollar bond-you? Are you paying off one loan and taking out another? How much debt is there? What do you lease? Are there going to be more rate hikes to pay off more debt. Is there money put aside for all the old pipes in the city which will eventually break? How much will it cost to replace other townships water plants or wells besides the ones mentioned?

Anderson has so many houses that are vacated, boarded up or falling down and more going into foreclosure. What base is going to be used, only houses that are occupied? There are more and more houses in Anderson that people are just walking away from because they can no longer afford them. This is due to job loss and not being able to find work because there are no jobs.

Can we get a printout of what our money is actually paying for now as far as the water bill? What is being leased and how much? What is going towards debt already incurred, and employees pay, etc.?

As people move out of Anderson because there are no over minimum wage jobs, those of us who are left have to make up the loss by paying more of the increases of utilities. Most of us are on a fixed income, a big percentage of young people are on welfare, and others are on assistance for their utility bills.

The bigger families get the highest increase in this rate hike, most younger people with children use more water and usually both adults work. This is tough for these young families. A lot of young adults out of college are moving home because of low paying jobs and student loans and they cannot afford separate housing.

We know the utilities need upgraded but those who can't afford an increase will it fall on us seniors in Anderson?

It seems like everything is going up, our pensions and social security are not. We saw that there hasn't been an increase since 2006-why now? Where does it end?

Now Anderson is looking into building the Mounds Lake Reservoir. This will benefit Indianapolis, not Anderson. Indianapolis wants to buy the water from the reservoir when it is needed. What if we need the water? This reservoir will decrease the number of residents in Anderson because the houses are in the lower income areas and businesses will be flooded. The lower income areas will probably not get enough for their houses to buy another in Anderson. This is supposed to bring more income to Anderson. This will just cause more increases especially in the tax base they will loose.
